## **SUNSWEET GROWERS INC. CHARLES T. YERXA SCHOLARSHIP FUND**

### **I. CANDIDATE REQUIREMENTS**

1. Must be a child or grandchild of a current Sunsweet Growers Inc. member or current Central or District Director and be prepared to commit to the requirements of this scholarship offer. Children and grandchildren include natural, adopted, or stepchildren.
2. Must be a graduating high school senior with a grade-point average of 3.0 or better on a 4.0 point scale for each quarter or semester from the beginning of the ninth grade through the first semester of the twelfth grade.
3. To be accepted for consideration, all applicants must comply with points 1. and 2. above and all applications **must** be accompanied by (in the same envelope):
  - a. Applicable transcripts sealed by the high school;
  - b. Three letters of reference (example: school officials, teachers, clergy, etc., not a relative)
  - c. A personal statement by the applicant of 500 words or less stating his/her goals and future expectations.
4. Successful applicants will receive first scholarship payment after providing Sunsweet Growers with official proof of full-time student status registration at a domestic college/university grading on a 4-point system and is accredited by an agency recognized by the U. S. Secretary of Education.

### **II. SELECTION PROCESS**

1. Candidates shall submit application to Scholarship Committee by April 3, 2026.
2. Recipients will be notified by April 30, 2026.

### **III. AMOUNT OF GRANT AND METHOD OF DISTRIBUTION**

1. The grant shall be for \$1,000 per year for 4 years.
1. \$1,000.00 shall be awarded at beginning of the recipient's first Fall term upon receipt of request for funds accompanied by official proof of full-time registration at a domestic college/university using a four-point grading system and is accredited by an agency recognized by the U. S. Secretary of Education. Subsequent payments will be made at the beginning of the next three Fall terms based on the following criteria:
  - a. official transcripts reflect a minimum grade-point average of 2.5 for each term of the previous year at a domestic college/university using a four-point grading system;
  - b. student has maintained full-time undergraduate status;
    - i. full-time status shall be deemed as 12 credits per quarter or semester;
  - c. student has provided official proof of full-time registration for the current Fall term;
  - d. student is attending a domestic college/university grading on a 4-point system and is accredited by an agency recognized by the U. S. Secretary of Education.
  - e. student has had no breaks in attendance other than summer session;
  - f. student requests funds.

### **IV. LACK OF QUALIFIED APPLICANTS**

If there are no qualified applicants, the funds will be held over for the following year.

### **V. CONTINUANCE OF GRANT**

Continuance of this grant shall be upon fulfillment of the requirements by the recipient.
